My name is Yi-Zen and I'm a second year graduate student at Yale. When I was in college at UC Berkeley I ran an amateur astronomy club which organized stargazing sessions for students and the public. Through this experience I came to realize that amateur astronomy can be rather inaccessible to people with mobility difficulties because of the restrictions imposed by the need to look through a telescope at a given height and position. I do not find that to be a good enough reason that the fascinating celestial sights should be limited to those who can look through a telescope.

I am working with the undergraduate astronomy club here at Yale (STARRY) to organize semi-regular stargazing sessions for people with disabilities both within and outside of Yale. The club uses a wheelchair accessible observatory at the corner of Edwards and Prospect streets, which has a 12" Meade telescope. I plan to hook up the telescope with my highly sensitive SBIG video camera and feed the images to a TV screen so that the images can be viewed by anybody and also by a large audience at the same time. The camera should be able to allow viewing of the brighter galaxies, nebulae, star clusters, and most certainly the planets and craters on the moon.

This project is in its infancy. I'd like to begin by setting up a electronic mailing list so that I can get in touch with interested people more easily. I'd like to invite you to get in touch with me if you would like to be informed of the latest developments and upcoming star parties, or if you just have some questions about my project. I hope to do at least one star party by the end of this year for people with disabilities so that people can see what this is all about. ### Are You Registered To Vote?

Elections are rapidly approaching and it is not too late to register to vote. Tuesday, November 2, 2004 is Election Day, which will encompass the national election for President of the United States, congress and local officials.

To register to vote visit the City of New Haven's Registrar of Voters office on the second floor of the Hall of Records at 200 Orange Street in New Haven. There is an accessible entrance at the ground floor with elevator access. In addition to being open from 9am to 5pm, Monday through Friday, they will be open for extended hours on the following dates for your convenience. Please bring with you the following in order to register: a Connecticut Drivers license or photo I.D., a Social Security Card, or a recent piece of mail.



Wednesday Oct 6 from 5 p.m. to 8 p.m. Saturday, October 16<sup>th</sup> from 10 a.m. to 2 p.m. Tuesday, October 19<sup>th</sup> from 5 p.m. to 8 p.m.

It is critical individuals with disabilities vote. Make your vote count!


## Link-Up and Lifeline Offer Telephone Discounts to Low-Income Individuals

Low-income phone-users may be eligible for two federal programs that offer telephone discounts for both wireline and wireless telephone services. Individuals who qualify for the Link-Up program will receive discounts of up to \$30 to hook up their phones. Another federal program, Lifeline, offers eligible individuals a monthly discount of \$6.75-\$9.50 on basic telephone services.

The exact amount of the monthly discount through Lifeline varies depending on where you reside. Since some states match Lifeline discounts, qualifying individuals may be able to still save more.

Those in the low- income group usually include Medicaid, food stamp, and SSI recipients as well as individuals receiving federal public housing assistance or Low-Income Home Energy Assistance (LIHEAP). Qualification requirements vary from state to state; to determine your eligibility and apply if eligible, please call your local telephone company. The toll-free number for SBC is 1-800-922-4605. You may also contact the state regulatory agency (such as the Public Utilities Commission).
