### Original idea for my capstone project:

My capstone project will be developing a district Pupil Services report via PowerPoint to present to the BoE using EdSight and distract data. I will use it as an opportunity to learn which district data I should be tracking and analyzing to inform programming and monitor district compliance.

# Plan of Action

- ★ Create a PowerPoint to present to the Board of Education with an end of year update and outlined department goals, data, programming considerations
  - <u>PowerPoint</u> was created and I had to determine which areas I wanted to collect data on and target areas to present to the BoE to influence decision making and funding for department programming and personnel
  - I determined that I would review my department goals for and progress made towards goal achievement for SY 22-23
  - I determined that I would collect data related to the district's special education prevalence rates going back to 2016. I also wanted to include total student population numbers in that data.
  - I wanted to provide a snapshot of the importance of mental health services in district and share 211/911 crisis call numbers
  - I wanted to review the supervision responsibilities of pupil services administrators
  - Introduce and highlight specialized program mission statements

# Plan of Action

- ★ Gather relevant data and information required to complete my PowerPoint
  - This involved using EdSight to determine prevalence rates for Somers Public Schools since 2016
  - Meeting with our district Data Specialist to review the EdSight information related to student enrollment and students with disabilities child counts
  - EdSight information was incorrect in a few areas which led us down a path of analyzing data collection processes for the district, PSIS historical counts and SEDAC recorded information. This was a very lengthy process
  - Email my support staff throughout the district for 211/911 numbers placed this school year for students in crisis
  - Utilize data in CT-SEDS for current information on IEPs and 504s within the district and those we are fiscally responsible for
  - Contact Diane Murphy at CSDE to review how prevalence rates are calculated

# Plan of Action

- ★ Meet with new Superintendent of Schools to Review PowerPoint
  - Met with interim superintendent to review department goals and highlights to include in my PowerPoint
  - Brought in our data specialist to review some discrepancies found between PSIS and SEDAC reporting and EdSight
  - Reviewed areas to target with current data regarding referrals and # of IEPs and 504s
  - Reviewed OOD placements
  - Met with interim and included our new superintendent to discuss the end of year PowerPoint and my goal to make this an annual report before the BoE budget is approved
  - Reviewed desired outcome of the PowerPoint presentation
